If the mare has not been ultrasounded or palpated and the breeding date is not known, EZ 2 Spot Ranch will arrange for a veterinary examination to determine the stage of pregnancy at the owner's expense. Mares who are determined by the veterinarian to be at risk of foaling during isolation or shipping will not be accepted for isolation and/or shipping until after foaling.

Terms of agreement

1. The cost of the equine isolation is as shown on the accompanying invoice. This includes: quarantine in USDA approved facility for the period specified by the country of destination, twice daily feeding, feeding of supplements if provided by owner/agent, grooming, halter and lead rope, preparation of International Health Certificate and/or any other required documents, required veterinary services, transportation in an approved trailer to the airport of departure and qualified attendants to accompany the equine on the trip. Daily turn out and blanketing services are also available and may be arranged on a case-by-case basis.

This does not include: transportation from the farm/ranch of origin to the isolation facility, veterinary services beyond those required by law, if needed, farrier service, if needed, and/or any additional special handling or needs. It also does not include any taxes, duties, fees or other costs that are required upon arrival in the country of destination.

2. Airfreight costs and U.S. government fees are subject to change without advance notice. EZ 2 Spot Ranch will notify the owner of the current cost at the time of booking the container, as well as any price increases during the isolation period as soon as possible.

3. Airfreight costs are based on use of a full container that is provided by the airline (designed to hold six miniature or three full-size equines). Additional costs will be incurred for custom-built crates that may be used for shipping single animals or smaller groups of animals. The cost of the crate & shipping will be determined by the size of the animal(s) for which it is built. Buyers who choose not to wait for a container to be filled with other buyers' animals may elect to have a crate built for their animals for certain destinations.

4. EZ 2 Spot Ranch will give you a possible starting date of the first available isolation period and a tentative date for shipping. However, EZ 2 Spot Ranch shall not be liable for any delays of either the starting date or the shipping date. EZ 2 Spot Ranch shall not be liable for any personal travel arrangements for buyer, owner, seller or agent.

5. A qualified veterinarian will exercise judgment of the health of the equine. The owner will be responsible for paying any and all veterinary and/or farrier expenses that are required during the isolation period.

6. The equine shall be in healthy condition, free from external and internal parasites, infections, contagious or transmissible diseases. A current negative Coggins, a copy of registration papers and a signed, dated bill of sale must accompany the horse. Please provide EZ 2 Spot Ranch with a current record of vaccinations and worming. Please notify EZ 2 Spot Ranch of any special health or nutritional matters.

7. EZ 2 Spot Ranch reserves the right to refuse to accept any equine which is (1) not in proper condition (2) is too far advanced in pregnancy to travel safely (3) does not halter, tie, lead and/or load and/or (4) does not have the required documents. If an untrained horse arrives for isolation at EZ 2 Spot Ranch, training may be provided at EZ 2 Spot's discretion at an additional cost to the buyer. The cost will be determined by the individual animal's needs. An estimated cost of training will be provided to the owner for approval. It is essential that equines be sufficiently trained in order to be haltered and handled for turn out and various required veterinary and grooming procedures and to lead, load and travel safely for both ground and air transportation.

8. Neither EZ 2 Spot Ranch nor any person associated with EZ 2 Spot Ranch shall be liable for the death, sickness, accident and/or injury to the equine.

9. The equine owner agrees to have EZ 2 Spot Ranch transport the equine at the owner's

risk. If for any reason the equine will not load and/or or will not be able to transport, the equine owner shall pay all of the additional expenses.

10. Payment for isolation, airfreight and all other fees and services is due at the beginning of the isolation period. The equine will not leave the isolation facility before the full payment has cleared our bank. In case of failure to pay, the owner agrees to the following rates: \$25 per day per equine while waiting for the next available flight and all fees and charges for a new isolation period and airfreight.

11. EZ 2 Spot Ranch's responsibility for the equine(s) ends when the animal is offloaded from the aircraft at the destination airport. At that point in time, the client and/or the client's agent(s) become responsible for the equine's care and welfare.

12. As with all mammals, changes in air pressure and temperature during flight can cause an equine's eyes and/or nose to secrete fluids. If your equine arrives with a runny nose or eyes, please recognize that this does not necessarily indicate illness, but that it is, in all likelihood, simply an effect of flying that will resolve itself in a reasonable amount of time.

13. Horses that "paw" or stamp their feet on the floor of the container during transit may show tenderness upon arrival.
